Board Celebrations

Board Member Dr. Mayfield, being a seven-year breast cancer survivor and October being Cancer Awareness Month, acknowledged district survivors and their family members.

Assistant Secretary Ryan Ray took a few moments to acknowledge the recent passing of Angela Fields. Ms. Fields was a former CISD alum and graduate of the Class of 2001.

Board Vice President Gary Grassia congratulated both Crowley High School and North Crowley High School Bands for each of their performances during recent UIL competitions. During his comments, he also commended NCHS Varsity Football Coach, Courtney Allen for attending the event accompanied by the NCHS Football Team to show their support of their band classmates.

Board President Dr. Hall, shared her pride and excitement about the newly constructed indoor practice facilities at both Crowley High School and North Crowley High School. The CHS Indoor Practice Facility dedication took place on Thursday, October 28, 2021. The event was well attended and students representing various district organizations were also in attendance. Dr. Hall commended and thanked all district stakeholders, staff and vendors including VLK Architects and Steele & Freeman for making this possible.

Dr. Hall introduced The Crowley ISD Board of Trustees Hero Award. During the presentation she shared the following statement:

We all know that “Heroes Work Here” in Crowley ISD, and this recognition will give us the opportunity to shine the spotlight on some of our heroes and share their stories with the entire community.

A Hero is defined as someone who is admired for courage or outstanding achievements, and our first recipient is so very deserving.

Her heroic actions saved the day for a group of our students who were riding the bus to school at Sue Crouch Elementary last week on Wednesday, October 20.

Bus monitor Roberta Kennard was sitting in the back of the bus with four young students who all have special needs.

The bus was turning onto Summer Creek Drive from Risinger Road after stopping at a stop sign when Ms. Kennard realized the bus driver was having a medical emergency and was slumped over the steering wheel.

Ms. Kennard immediately ran to the front of the bus, pulled the air break, and stopped the bus. She then called dispatch on the radio for help.

Another bus driver nearby quickly arrived and started CPR on the bus driver until medical crews arrived.

The bus driver who suffered the medical emergency was taken to the hospital where sadly, he died a few hours later. His name was Maurice Brown. He had been with Durham Transportation for three years. Our thoughts and prayers are with his family during this difficult time.

Because of Ms. Kennard’s quick actions, the school bus was safely brought to a stop without hitting any vehicles or anything else. And, the four students were all safe.

She has been with Durham Transportation for five years, and she is the first recipient of the Crowley ISD Board of Trustees Hero Award.

The CISD Board of Trustees presented Ms. Kennard a token of appreciation for her valiant actions.


