Annual Report – Fiscal Year 2022 – 2023 Crowley ISD Rebates from Purchasing Cooperative Cash-Back Rebate Program Participation

Crowley ISD is a member of several national, state, and other authorized Purchasing Cooperatives/Cash-Back Rebate Programs. Purchasing Cooperatives/Cash-Back Rebate Programs serve as agencies that help school districts and other governmental agencies to streamline the procurement process, enabling them to increase their purchasing power by pooling their needs to receive a better value for purchased goods and services than a single entity might be able to receive on its own. Rezoning of School Attendance Zone Boundaries

District administrators provided an overview of the process and timeline for rezoning school attendance boundaries based on new residential development, student enrollment and campus capacity figures.

Grant Awards: Learning Acceleration Support Opportunities (LASO) 2 Award Notification

Additional Days School Year- Summer Learning Accelerator Amount Awarded: \$476,088 Grant Funds Available: March through September 2024

High-quality, evidence-based summer learning programs help to prevent summer slide, i.e., learning loss created by the lack of student engagement in rigorous content between academic school years. Prekindergarten through 5th grade campuses who meet Additional Days School Year (ADSY) eligibility requirements in the 2023-2024 school year are eligible for this grant. This grant program guides LEAs through a 3-month accelerated support planning process to design a summer learning program aligned with research-based best practices in academics, operations, and enrichment activities.

School Action Fund- Planning Amount Awarded: \$370,000 Grant Funds Available: March through September 2024

The School Action Fund (SAF) grant provides technical assistance, resources, and grant funds to support the planning and implementation of school actions for, and at, individual campuses. School districts also receive support in adopting a broader continuous improvement strategy to improve schools and provide parents and families with the schools and programs they want, need, and deserve. A maximum of six grants will be awarded to any individual LEA across all actions.

Technology Lending Grant Amount Awarded: \$180,000 Grant Funds Available: February 2024 through April 2025 Purpose of Grant: The Technology Lending Grant program provides students equipment necessary to access and

use digital instructional materials at school and at home.

This item will be brought back during a future board meeting for consideration and possible action.

Curriculum Adoptions - Proclamation 2024

Proclamation 2024 calls for the adoption of instructional materials in K-12 Science and Personal Financial Literacy and Economics.

A team of coordinators, teachers and principals have been working together throughout the year to identify high-quality publishers and materials for adoption in Crowley ISD. Samples of top publishers were presented to all teachers. All resources have been designated High Quality Instructional Materials by the State Board of Education. Top publishers will be on public display at upcoming district events in person and via zoom as well as the Administration building through Friday, March 29. An online feedback form is available for input from employees, students, board members, and community members.

The final recommendation for adoption will be brought before the board as an action item in April.This item will be brought back during a future board meeting for consideration and possible action.

2024-2025 School Calendar

The District is in the final planning stages of developing the 2024-2025 school calendar.

A calendar survey with two draft options will be launched Monday, Feb. 26 for parents, students and staff.

Draft A features: -No change to school day start/end times -Student/Staff Days: *169 student instructional days *187 teacher contract days *15.5 professional development days *2.5 teacher-directed staff workdays

Draft B features: -Change to school day end times: *Elementary dismissal: 3:30 p.m. (additional 10 minutes) *Middle dismissal: 3:55 p.m. (additional 10 minutes) *High dismissal: 4:30 p.m. (additional 15 minutes)

-Why? This change to school day dismissal times creates: *Additional four-day weeks *Instructional days that are the same length at elementary, middle and high school *Designated teacher-directed staff workdays, parent/teacher conference days and campus collaboration days

*Additional time for high school students traveling between home campus and CTE Center

-Student/Staff Days:

- *164 student instructional days
- *187 teacher contract days
- *10 campus collaboration days
- *7.5 professional learning days
- *3.5 teacher-directed staff workdays
- *2 parent/teacher conference days

The draft calendars are also being reviewed by the District PIT team, the District-Wide Educational Improvement Council (DWEIC) and a principals before being brought back to the School Board possible action at the March 7, 2024 meeting. This item will be brought back during a future board meeting for consideration and possible action.

1882 Partnerships Call for Proposal(s)

Crowley ISD is set to release a formal announcement inviting organizations defined by districtauthorized subchapter C to submit proposals for the redesign of their middle schools. CISD will thoroughly review the proposals received, as they seek to create or expand highquality schools within their jurisdiction. The main objective of the Call for Proposal (CFP) is to identify innovative ideas and proven models that can improve educational outcomes and provide students with access to excellent schooling options. The ultimate goal of the CFP initiative is to establish a pipeline of potential partner organizations that can operate schools in CISD. For the upcoming call, CISD is prioritizing innovation partnerships for their middle schools. This item will be brought back during a future board meeting for consideration and possible action.
