# Regional Day School Program for the Deaf (RDSPD) Shared Service Agreement/Membership

There are three basic systems in place that provide public deaf education services in the state of Texas. A student may receive services from one or more of these systems:

- -LEA Local education agency (home school district)
- -RDSPD Regional Day School Programs for the Deaf
- -TSD Texas School for the programs were developed to help maximize resources and staff, to better serve students throughout the state.

Each RDSPD is unique and may offer various services depending on the number of students they serve, as well as other factors. Crowley Independent School District (Crowley ISD) is the Regional Day School Program for the Deaf for the following Region 11 school districts: Alvarado, Burleson, Cleburne, Everman, Joshua, Johnson County Shared Services Arrangement (Godley, Grandview, Keene, Rio Vista)

Crowley ISD serves as the Fiscal Agent for the Regional Day School Program for the Deaf. The contract between the Fiscal Agent and shared service arrangement district is renewed annually by the Board of Trustees.
