Current Late Work Policies



Campus late work policies must align with district grading philosophy

Penalties may be assigned for late work according to campus late work policy

Current Late Work Policies



Secondary

Assignments late 1 school day will be reduced by 10%

Late assignments any day thereafter will be reduced up to 50% with a six weeks grading period

Teacher sets the final cut off date for late work with campus and district guidelines

Guiding Considerations



- Consistency
- Clarity
- Incentive

Proposed Late Work Policy



Proposed District Late Work Policy

- 1 day late = 90% of original grade
- 2 days late = 80% of original grade
- 3 days late = 75% of original grade

After 3 days, a student has until the Friday one week prior to the end of the marking period to submit late work. The work will earn 70% of the original grade.

Students whose classes meet on an alternating (A/B) schedule will have penalties assigned per class period.

Teachers retain the ability to use professional judgment and discretion in extenuating circumstances.
