



MUTUAL AID AGREEMENT

Parties

This Mutual Aid Agreement (MAA) is entered into between Crowley Independent School District, hereinafter “Crowley ISD,” whose address is 1900 Crowley Pride Drive, Fort Worth, TX 76134, and Fort Worth Presbyterian Church, hereinafter “Fort Worth Presbyterian,” whose address is 6251 Oakmont Trail, Fort Worth, TX 76132.

Purpose

Crowley ISD is required to have a safe area to evacuate its students and staff in the event an emergency situation exists on the property. Crowley ISD expects the need to use Fort Worth Presbyterian’s facilities to be quite rare and would only be used if Crowley ISD is unable to return to their property or if weather conditions will not allow the students and staff to remain outdoors on their property during an emergency evacuation. Crowley ISD will require space for up to 300 people.

Fort Worth Presbyterian is located at 6251 Oakmont Trail, Fort Worth, TX 76132. Fort Worth Presbyterian is required to have a safe area to evacuate its students, staff, and or members in the event an emergency situation exists on the property. Fort Worth Presbyterian expects the need to use Crowley ISD’s facilities to be quite rare and would only be used if Fort Worth Presbyterian is unable to return to their property or if weather conditions will not allow the students, staff, and or members to remain outdoors on their property during an emergency evacuation. Fort Worth Presbyterian will require space for up to 300 people.

Responsibilities and Working Arrangements

The following provisions describe the mutual aid agreement between Fort Worth Presbyterian and Crowley ISD regarding Crowley ISD’s use of a portion of Fort Worth Presbyterian’s facilities. This MAA also applies to Fort Worth Presbyterian’s use of a portion of Crowley ISD’s facilities. This MAA may be terminated with the written consent of both Crowley ISD and Fort Worth Presbyterian.

In the event students and staff of Crowley ISD must leave their property, students and staff will be transported by foot to the designated area of the church. Crowley ISD will be responsible for notifying the minor(s)’s parents and caring for any and all minors under their care until they are picked up.

In the event individuals of Fort Worth Presbyterian must leave their property, individuals will be transported by foot to the designated area of the campus. Fort Worth Presbyterian will be responsible for notifying the minor’s parents and caring for any and all individuals under their care until they are picked up.



MUTUAL AID AGREEMENT

Term

This MAA shall automatically renew annually on the anniversary of the effective date each year unless notice is provided by either party that the MAA will not be renewed. Either party may terminate this MAA for any reason with seven days' notice to the other party.

Release of Crowley ISD

To the extent permitted by the laws and constitution of the State of Texas and without waiver of governmental immunity, Fort Worth Presbyterian hereby releases, acquits, and forever discharges Crowley ISD and all of its affiliates of, from, and with respect to any and all liability arising from any and all obligations, causes of action, suits, promises, agreements, losses, damages, charges, expenses, challenges, contests, liabilities, costs, claims, and demands of whatsoever nature, known or unknown, which may ever accrue in the future to Fort Worth Presbyterian in connection with Crowley ISD's use of the Evacuation Location of Fort Worth Presbyterian. Fort Worth Presbyterian further indemnifies Crowley ISD for all obligations, causes of action, suits, promises, agreements, losses, damages, charges, expenses, challenges, contests, liabilities, costs, claims, and demands of whatsoever nature that may arise out of this MAA.

Release of Fort Worth Presbyterian

To the extent permitted by the laws and constitution of the State of Texas and without waiver of governmental immunity, Crowley ISD hereby releases, acquits, and forever discharges Fort Worth Presbyterian and all of its affiliates of, from, and with respect to any and all liability arising from any and all obligations, causes of action, suits, promises, agreements, losses, damages, charges, expenses, challenges, contests, liabilities, costs, claims, and demands of whatsoever nature, known or unknown, which may ever accrue in the future to Crowley ISD in connection with Fort Worth Presbyterian's use of the Evacuation Location of Crowley ISD. Crowley ISD further indemnifies Fort Worth Presbyterian for all obligations, causes of action, suits, promises, agreements, losses, damages, charges, expenses, challenges, contests, liabilities, costs, claims, and demands of whatsoever nature that may arise out of this MAA.

Fort Worth Presbyterian and Crowley ISD agree to the terms and conditions set forth herein, effective as of _____, 2022.
