### **Celebrations / Board Points of Pride**

Dr. La Tonya Mayfield, congratulated the Crowley High School Boys Soccer Team program on claiming the District 8-5A Championship over Burleson High School. She added, "With the win, the Eagles improved to 17-4-2 overall and 10-3-1 in district play. Although the season came to an end we are very proud our athletes for the run!"

**Future Action Item(s)**

**Elementary School Boundary Adjustments**

Crowley ISD is planning minor boundary adjustments to some elementary school attendance zones for the 2022-2023 school year due to fast growth in our district. With more families choosing our schools, the district remains committed to providing space for a safe, secure learning environment for all students, and these adjustments will help prevent overcrowding in schools that are approaching capacity levels.

If approved, a small number of students who attend the following schools would be impacted:

- June W. Davis Elementary (rezoning some students to Sue Crouch and Dallas Park)
- Deer Creek Elementary (rezoning some students to Bess Race)
- Bess Race Elementary (rezoning some students to S.H. Crowley)
- Meadowcreek Elementary (rezoning some students to Jackie Carden)

The district will be holding two virtual town hall meetings to discuss the proposed boundary adjustments on Wednesday, April 6 at 12 p.m. and 6 p.m. on Zoom.

### **Construction Manager at Risk Selection for Elementary School 16**

The District is currently engaged in the process of selecting a Construction Manager At Risk (CMAR) for the construction of Elementary School 16. This process is being conducted as a two (2) step process:

Step (1) entails a solicitation of potential CMAR firms through a Request for Qualifications (RFQ). A short list of responsive CMAR firms is then established and those firms are notified. Step (2) will entail the submission/review of General Conditions from the short listed firms. These General Conditions proposals will then be evaluated by a District committee and a recommendation will be submitted to the Board of Trustees at the April 14, 2022 Board meeting.

### **External Legal Counsel Request for Qualifications (RFQ)**

Crowley ISD's current External Legal Counsel Services RFQ is set to expire on 6-30-2022.

There are no additional option years available, hence, a new RFQ has been advertised for districtwide external legal counsel services.

Crowley ISD has a total of 15 firms awarded to the current RFQ that will soon be expiring. All 15 firms have been advised and invited to submit to the new RFQ that advertised on 3-24-2022. This RFQ will close on 4-13-2022 promptly at 2pm.

### **Employee Healthcare Clinic Services Request for Proposals (RFP)**

An RFP for the Employee Healthcare Clinic Services was issued March 3, 2022. The response deadline is March 30, 2022. CISD is seeking an established healthcare organization to provide CISD employees, their spouses and eligible dependents with a healthcare clinic that focuses on non-emergency outpatient care that's routine, acute care and/or preventative. The respective organization will provide services for a base fee, regardless of insurance coverage. The period of performance will be August 1, 2022 through July 31, 2023 with the option to renew for an additional four (4) years in one (1) year increments at the discretion of the District.

The current CISD Employee Healthcare Clinic Services expires July 31, 2022 and is located at 5701 Bryant Irvin Rd., Fort Worth, 76132, through the TX Health Physicians Group.

### **Refuse Service Bid**

Crowley ISD's current Refuse Service Provider is Republic Services of Fort Worth, Texas. The first (1st) optional year will expire on 6-30-2022. The district has elected to extend the agreement into the second (2nd) optional year which will be from 7-1-2022 through 6-30-2023.
