### **Contract Renewal with Tarrant County Tax Office for Collection of Taxes**

The District currently contracts with Tarrant County Tax Office to collect Ad Valorem taxes on behalf of Crowley ISD. The Tax Office is offering a three-year contract, as a convenience, instead of the annual renewal.

#### Possible Modifications to Board Policy DEAB (LOCAL): Workweek Defined

"For purposes of Federal Labor Standards Act (FLSA) compliance, the workweek for District employees shall begin at 12:00 a.m. Saturday and end at 11:59 p.m. Friday."

The administration is recommending that CISD change the definition of the workweek to read: "For purposes of FLSA compliance, the workweek for District employees shall begin at 12:00 a.m. Sunday and end at 11:59 p.m. Saturday."

With the new definition, the District is aligning the workweek to more closely resemble the public's understanding. It will eliminate any confusion in planning and calculating overtime for CISD non-exempt employees.

This new definition shall be implemented by September 1, 2022 after Board approval and ample notice to all CISD employees.
