- LEA - Local education agency (home school district)
- RDSPD - Regional Day School Programs for the Deaf
- TSD – Texas School for the Deaf



- These programs were developed to help maximize resources and staff, to better serve students throughout the state.
- Each RDSPD is unique and may offer various services depending on the number of students they serve, as well as other factors.

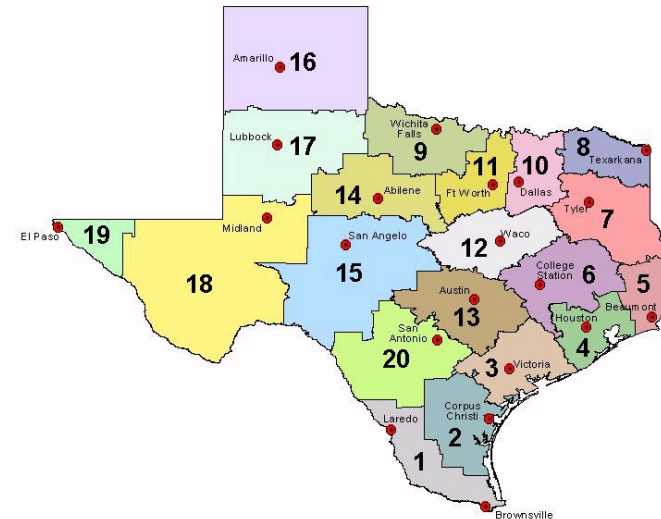


RDSPD Shared Service Agreement

RDSPD Shared Service Agreement



- The arrangement is legally bound under an annual Shared Services Agreement/Contract.
- The agreement/contract is issued to the participating school districts in late spring for approval from their District.
- The Crowley ISD Superintendent and Board of Trustees are the final approvers.



SHARED SERVICES ARRANGEMENT AGREEMENT

CROWLEY INDEPENDENT SCHOOL DISTRICT'S REGIONAL DAY SCHOOL PROGRAM FOR THE DEAF (RDSPD)

This Agreement is made and entered into this ____ day of _____, 2019, by and between the CROWLEY INDEPENDENT SCHOOL DISTRICT (Crowley ISD), and the Shared Services Arrangement Districts, including, but not limited to, Alvarado, Burleson, Cleburne, Everman, Joshua and the Johnson County (Godley, Grandview, Keene, Rio Vista) Special Education SSA hereinafter referred to as the SHARED SERVICES AGREEMENT MEMBERS. Crowley ISD and the SHARED SERVICES AGREEMENT MEMBERS, hereinafter referred to as the "PARTIES", have agreed, and by the execution of this contract, are bound to the obligations and performances hereinafter described.

AUTHORITY

The Crowley ISD Board of Education is authorized to enter into this contract under §29.007 of the Texas Education Code.

The Crowley Independent School District's Regional Day School Program for the Deaf (Crowley RDSPD) will be operated in accordance with §29.007 and §§30.081-30.087 of the Texas Education Code, and §29.1080 of the State Board of Education Rules, codified at 19 Tex. Admin Code §89.1080.

The SHARED SERVICES AGREEMENT MEMBERS covenant that they have the legal authority, pursuant to state law, to enter into this contract and perform the services described herein. The person signing this contract on behalf of the SHARED SERVICES AGREEMENT MEMBERS hereby warrants and guarantees that he/she has been duly authorized by the SHARED SERVICES AGREEMENT MEMBERS to execute the contract and legally bind the SHARED SERVICES AGREEMENT MEMBERS to the performance described herein.
