#### 2022-2023 School Calendar

The district is in the planning stages of developing the 2022-2023 school calendar that maximizes instruction time to help all students thrive. Drafts of the calendar are currently being reviewed by the Executive Leadership Team, the District-Wide Educational Improvement Council (DWEIC) and principals before being brought to the School Board possible action at a future meeting.

## 2022-2023 Additional Days School Year (ADSY) Calendar

The 2022-2023 Additional Days School Year (ADSY) Calendar will add 30 additional days to the academic school year for the students who attend David Walker Elementary and possibly an additional (ADSY) campus. Major district holidays and breaks will align with the traditional district school calendar. The ADSY calendar will be submitted to TEA in March of 2022.

#### May 7, 2022 Board of Trustees Election – Order of Election

A general election will be held May 7, 2022 for the purpose of electing three School Board Trustees (Places 5, 6 and 7) to serve on the Crowley ISD School Board.

HB 1, passed in 2006, requires district trustee elections to be held on the same date as 1) the election for members of the governing body of a municipality located in the district or 2) the general election for the state and county officers. The voters of a joint election will be served by common polling places consistent with Election Code 271.003(b). The finalized Order of Election for the May 7, 2022 Board of Trustees election will be presented for discussion and action during the January 27, 2022 Regular Board Meeting.
