#### **Celebrations / Board Points of Pride**

Trustee Mayfield shared about recently attending a NC 9<sup>th</sup> Panther Pearls meeting. During her comments she stated "it was a privilege to attend this meeting." The group of young ladies work to encourage, uplift and to cultivate our young ladies as they being to mature and matriculate through high school." Dr. Mayfield commended the campus principal, Mrs. Colecia Williams the group founder, Ms. April Carter Brown, as well as the student group members for working in conjunction with the Tarrant Area Food Bank to provide 3,112 meals to families of the City of Fort Worth.

Trustee Davis stated "our district motto for the 21 – 22 school year is 'Act like a family...work like a team.' Across the district, in every department, staff members have stepped up to support our students. Regardless of position, Crowley staff is working with HR to fill substitute vacancies. She added "we are all hands-on deck for arrival, dismissal and lunch to ensure student learning can continue." During her closing comments, Trustee Davis commended students representing the NCHS Honor Society and the Black Student Union for "showing up" in great numbers to support the Tarrant Area Food Bank distribution at Jackie Carden Elementary on Tuesday, January 18, 2022. Each month, on the third Tuesday of the month, The Tarrant Area Food Bank brings its mobile pantry to Jackie Carden Elementary School.

Board Assistant Secretary Ryan Ray recognized Coach Cates and the NCHS swim team for advancing to Regionals on February 4<sup>-5</sup> in Mansfield. All six relays are moving on to regionals,

the boys 200 free play placed 3<sup>rd</sup> overall, and Ryan Luong beat a school record in the 100 breaststroke that was set in 2000.

During his closing comments, Trustee Ray also thanked CISD staff for all of the work that has been done to help decrease the number of positive COVID cases.

Board Secretary Nedra Robinson shared that on January 5, 2022 over 1,400 CISD educators logged on virtually to prepare themselves for the second semester. Susanne Malone, the Clinical Director of MHMR, led sessions on trauma informed care for educators and how trauma impacts the brain. Families were able to visit tables and hear presentations to help them better understand the various classes and programs available to students. Dr. Hall added "I want to commend Principal Buckhalton for the innovation, creativity and attention to detail that was given while planning this event to help ensure that our students and parents are well informed about making decisions that will impact their high school careers as they move forward.

## Texas Music Educators Association (TMEA) All-State Band

Aaron Indolos, a member of the North Crowley High School band, will perform with the Texas All-State Jazz Ensemble in San Antonio, Saturday, Feb. 12 as part of the 2022 Texas Music Educators Association Clinic/Convention.

Aaron was chosen for this prestigious honor through a competitive process held this year across the state at district, region, and area levels. Competing against jazz bass trombone players from all across the state, he placed third overall. Aaron is a student of Logan Davis and plays at school under the direction of Christopher Sample who is a member of the Texas Music Educators Association, a 14,000+ member organization headquartered in Austin.

This is Aaron's first time to perform as a member of a TMEA All-State organization. He is the son of Martin and Rosalyn Indolos.

All-State is the highest honor a Texas music student can receive. 1,875 students are selected through a process that began with over 70,000 students from around the state vying for this honor to perform in one of 18 ensembles. This competitive process begins throughout the state in auditions hosted by 33 TMEA Regions. Individual musicians perform selected music for a panel of judges who rank each instrument or voice part. From this ranking, a select group of musicians advances from their Region to compete against musicians from other areas in eight TMEA Area competitions. The highest-ranking musicians judged at the TMEA Area competitions qualify to perform in a TMEA All-State music group. Only the top 2.6% of musicians who initially audition become All-State musicians.

# National Association for the Education of Young Children (NAEYC) Accreditation for the Employee Child Development Center

The Crowley ISD Employee Child Development Center has earned accreditation from the National Association for the Education of Young Children (NAEYC)—the world's largest organization working on behalf of young children. There are over 380 licensed programs in Fort

Worth and only eight are accredited by NAEYC. The journey to accreditation was led by Kenya Jackson, Director of the CISD Employee Child Development Center.

# **Buyboard Purchasing Cooperative Rebate**

Crowley ISD is a member of the local government purchasing cooperative, BuyBoard. The cooperative helps school districts and other government entities streamline the procurement process and increase our purchasing power. Each year, the cooperative issues rebates to its members proportional to the amount of their purchases on the BuyBoard. The district allows the cooperative to collect a vendor fee up to two percent of the purchase price paid, and those fees are then provided as a rebate to the district. In order to comply with TEC 44.0331, the district must report the annual rebate amount to the Board.

Crowley ISD has received a rebate check of \$64,271.00 for the 2020-21 fiscal year as a result of the district's purchases made through the cooperative.

In the last year, CISD has used the BuyBoard to purchase a variety of products, including services, supplies and equipment.
